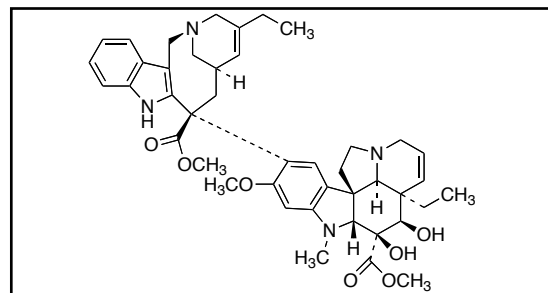

4. FIRST AID MEASURES

General Advice

Personal precautions

Methods and materials for containment and cleaning up

7. HANDLING AND STORAGE

Precautions for safe handling

Keep container tightly closed in a dry and well-ventilated place. Moisture, light and temperature sensitive. Store at -20°C under inert atmosphere.

Respiratory protection
