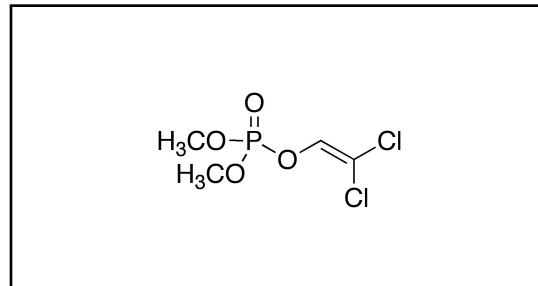

8.2 Exposure Controls

Appropriate Engineering Controls
