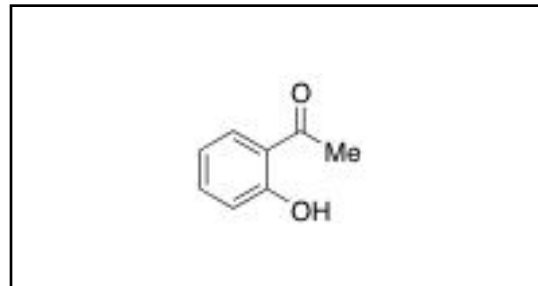

Personal Protective Equipment
