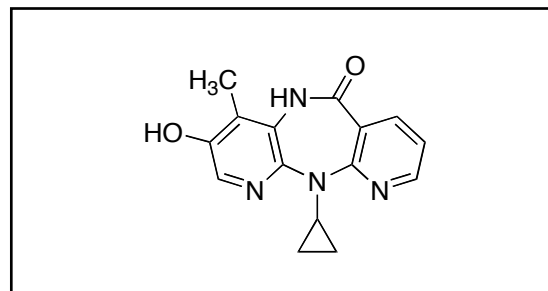

4. FIRST AID MEASURES

Personal precautions

Methods and materials for containment and cleaning up
