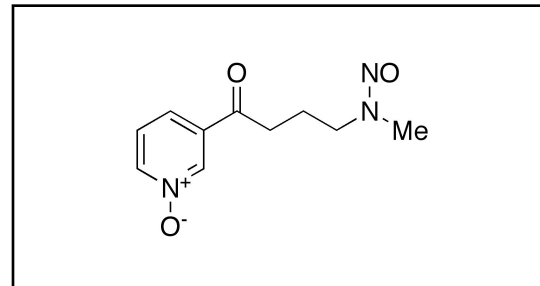

#### **Appropriate Engineering Controls**

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

#### **Personal Protective Equipment**

#### **Eye/Face Protection**

Gloves used for incidental exposures (splash protection) should be designated as "chemical resistant" by EU standard EN 374 with the resistance codes corresponding to the anticipated use of the material. Unrated gloves are not recommended.

Suggested gloves: AnsellPro Sol-Vex nitrile gloves style 37-175, 15 mil thickness.  
Penetration time has not been determined.

Gloves used for prolonged direct exposure (immersion) should be designated "chemical resistant" as per EN 734 with

the resistance codes corresponding to the anticipated use of the material.  
Suggested gloves: AnsellPro Viton/Butyl gloves style 38-612, 4/8 mil thickness.  
Penetration time has not been determined.

These recommendations may not apply if the material is mixed with any other chemical, or dissolved into a solution. A risk assessment must be performed to ensure the gloves will still offer acceptable protection.

### Respiratory Protection
