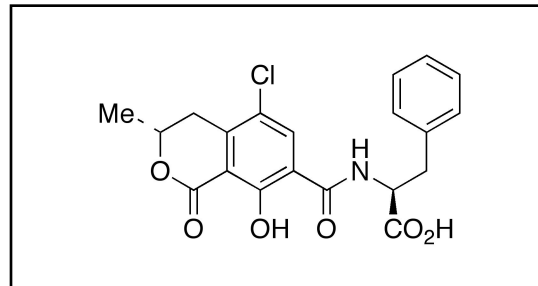

### 8.1 Control Parameters

#### Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.
