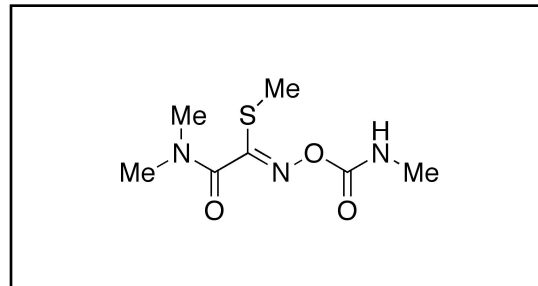

#### Appropriate Engineering Controls
